The Sponsor and the Local Little League are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein. The Sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: "Sponsorship at Keystone Little League." Banner advertising does NOT give the Sponsor the right to use the word "official" in connection with its Sponsorship. Use of the "Keystone logo" or any other logo of Little League Baseball and Softball is prohibited, unless permission is expressly granted in writing by Little League International.
